Through your support, we were able to hold a record year of fundraising! Our in-person Education Celebration gala shattered previous net profits, while our annual campaign continued to steadily grow.

We know the exceptional educators in NAFC schools give all they can to make sure their students succeed. To help them along in their effort, we are proud to offer the opportunity for any educator in the district to apply for up to \$500 a year in Great Classroom Project funding. These classroom grants are used to provide additional resources to creative teachers for learning opportunities that enhance the educational and curricular objectives of their classrooms.

For the past two years, educators were also able to apply for Covid-19 response resources. This included cleaning supplies, PPE, and digital and online resources for e-learning.

JUNIOR ACHIEVEMENT



Junior Achievement of Kentuckiana is the region's leading provider of life-changing economics programs for students. During the 2021-2022 school year, the entire 5th grade student body, about 900 students, participated in Junior Achievement's BizTown and the entire 7th grade student body, about 900 students, participated in JA Finance Park through funding from the Education Foundation. The Education Foundation is proud to send our young entrepreneurs through this program every year.

JA BizTown is a state-of-the-art interactive free enterprise laboratory located in Louisville where students play real life roles as citizens of their very own mini town.

JA Finance Park is a month-long economics education program which culminates with a visit to a simulated city where students put into practice what they've learned about economic options and the principles of budgeting.


All NAFCS students are sent through Junior Achievement in Memory of James Robinson.

IMAGINATION LIBRARY

This year is a milestone year for Dolly Parton's Imagination Library of Floyd County. We are celebrating the delivery of 500,000 books to our community's children since the program began in 2009. This accomplishment would not be possible without the support of our current funders: The Caesar's Foundation of Floyd County, Metro United Way, City of New Albany Redevelopment Commission

and Samtec, along with countless individuals. Half a million books fill the shelves of home libraries across our county. More importantly, these books are in the hands and hearts of children and their parents as they enjoy family reading time. EDUCATIONAL TOURS

The Foundation is proud to provide funding to elementary students for admission and transportation to numerous educational tours to local historical and cultural

experiences. Because of pauses on field trips due to COVID-19 precautions from the past two years, we were able to double the amount of field trips made available this school year. Many K-4th grade students were able to make visits to two important locations like the Louisville Zoo, Stage One Family Theatre, Derby Dinner Playhouse, Falls of the Ohio, Scribner House, Culbertson Mansion, Town Clock



Church, and Corydon State Capitol.



COLORS OF THE WORLD

In the Fall of 2021, we provided 5,000 packs of Crayola multicultural crayons and markers to every pre-school through 4th grade classroom in NAFCS. This project was made possible through the generosity of a grant from the Duke Energy Foundation. In addition to using the new materials throughout the school year, students created a personal self-portrait with these new resources. Through the help of elementary art instructors, we were able to assemble over 4,250 selfportraits into diverse "quilts". The beautiful patchworks

were on display at the NAFC Public Library as a part of the Spring Art Show.

The NAFC Education Foundation is an official partner with the Floyd County Chapter of Blessings in a Backpack. This group of volunteers is dedicated to making Floyd County a "hunger-free zone" for all elementary school children. In conjunction with the national Blessings in a Backpack organization, the Floyd County Chapter aims to make sure that approximately 1,300 NAFC school children who rely on the federal free and reduced lunch program for their weekly meals, don't go hungry on the weekend when school is closed.

Once a week for 40 weeks of the school year, volunteers pack backpacks of food to send home with eligible NAFC students. This food keeps hunger pangs at bay so the students can return to school Monday morning nourished and ready to learn.

\$115 a year will provide hunger-free weekends to a child in need

Floyd County's Chapter of Blessings in a Backpack is one of the largest in the country, having made the commitment to create a county-wide hunger-free zone by providing food to pre-K through 4th-grade students in need at all 9 elementary schools, and 5th and 6th-grade students at all 3 middle schools.

IST YEAR TEACHER GIFTS

Many Education majors finish college and move into their first positions as teachers with little to no help. Can you imagine being responsible for purchasing the numerous supplies and materials needed for a classroom with 20-30 students? This is why the Education Foundation chose to award 60 educators, new to NAFCS, with \$100 gift cards to Teachers Pay Teachers. Teachers face hundreds of dollars in out-of-pocket expenses to provide for their students. The Education Foundation is proud to facilitate a smoother transition into becoming a NAFC educator.
